UST poses a current or future threat to the environment, the UST owner can be required to perform a site assessment and, if necessary, corrective action. The first challenge with these USTs is locating them. For those located, the second challenge is identifying and finding the owner. Finally, many of these tank owners will either resist regulatory responsibility, or be financially unable to comply. For the purposes of this report, USTs for which there is no known or financially viable owner will be classified as orphaned. EPA estimates there are approximately 152, 000 abandoned unregistered USTs. As of September 1999, there were approximately 760, 000 registered USTs, some of which have been abandoned. While no one knows how many of these have been abandoned, based on the professional judgment of state UST managers, EPA estimates approximately 5 percent, or 38, 000 active USTs have been abandoned.
